**Memorandum For:** Cpt Bautista

**Subject:** Statement of Religious Beliefs for PFC Aaron Travis

1. I previously filed a Request for Religious Exemption on 25 Aug 21, to exempt me from receiving the mRNA COVID-19 Vaccine. This letter clarifies my religious beliefs in support of that request.

2. My foundational Christian beliefs are best described by selective quotes from the Holy Bible. Likewise, my Religious Objection to the mRNA Vaccine is also based on descriptions in the Scriptures that very explicitly characterize it as the "Mark of the Beast," as a literal branding mark, a tattoo that transfers ownership of the person's Soul to Lucifer. I will clarify those concepts here.

3. My Salvation is based upon my belief in and acceptance of the LORD Jesus Christ as my personal Savior. Furthermore, the Bible specifically instructs me that the LORD Jesus Christ is the only begotten Son of God, and that my only path to avoid eternal damnation is to believe in these Spiritual Truths contained within the below referenced verses - to include a specific warning to **not** worship any other deities or gods. (That includes not getting a vaccine that transforms my blood.)

- The LORD Jesus Christ is the Son of God, manifest in human form.
- The LORD Jesus Christ died for our sins, and was resurrected by God 3 days later.
- The death and resurrection of the LORD Jesus Christ qualifies Him to be our Savior.
- Entrance into Heaven is 100% based upon belief in God and not anything we can earn.
- We absolutely cannot worship any other idol or deity, or we will suffer the wrath of God.
- Human life is in the blood. The Crucifixion of the LORD Jesus Christ was the Atonement for our sins, which opened a pathway to Heaven. But only for those that accept the LORD Jesus Christ.

4. Scriptures that confirm the above Spiritual Truths:

a. **John 3:16**

*"For God so loved the world that He gave His only begotten Son, that whoever believes in Him should not perish but have everlasting life."*

b. **Ephesians 2:8-9**

*"For by grace you have been saved through faith, and that not of yourselves; it is the gift of God; Not of works, lest anyone should boast."*

c. **Exodus 20:3**

*"You shall have no other gods before Me."*

d. **Leviticus 17:11**

*"For the life of the flesh is in the blood, and I have given it to you upon the altar to make atonement for your souls; for it is the blood that makes atonement for the soul."*

5. The specific prohibition in Revelation to **not** take the Mark of the Beast is what confirms that the mRNA Vaccine is indeed the Mark. The description of the Mark precisely matches the mRNA Vaccine characteristics. Furthermore, the timing of the 2020 COVID-19 pandemic and the development and approval of the Jab in 2021 validate that the Vaccine is the Mark of Lucifer.

6. Scriptures that confirm the mRNA Vaccine is the Mark of the Beast. Note that the Book of Revelation was published in approximately 96 AD, so the connection between the mRNA Jab and the Mark of the Beast will be identified by common unique characteristics, as described below:

a. **Revelation 13:16-17**

*“And he causes all, the small and the great, and the rich and the poor, and the free men and the slaves, to be given a mark on their right hand or on their forehead, and he provides that no one will be able to buy or to sell, except the one who has the mark, either the name of the beast or the number of his name.”*

b. **Revelation 13:18**

*“Here is wisdom. Let him that hath understanding count the number of the beast: for it is the number of a man; and his number is Six hundred threescore and six.” (666)*

c. **Revelation 14:9-10**

*“Then another angel, a third one, followed them, saying with a loud voice, “If anyone worships the beast and his image, and receives a mark on his forehead or on his hand, he also will drink of the wine of the wrath of God, which is mixed in full strength in the cup of His anger; and he will be tormented with fire and brimstone in the presence of the holy angels and in the presence of the Lamb.”*

7. Major Prophetic Events in the Scriptures usually have Astrophysical alignments to herald their arrival. For example, the Star of the East was used by the Wise Men to navigate and find the baby Jesus in Bethlehem. In the 21<sup>st</sup> century, we have an astrophysical alignment found in Revelation Ch 12, versus 1-2, that indicates we are in the last chapter of human history. That alignment occurred on **Sept 23<sup>rd</sup>, 2017** and was a marker that prophetic events were manifesting. My research shows a similar alignment happened on **August 5<sup>th</sup>, 3985 BC**. That represents the 6,002 year “Bookends” of human history, and corresponds with Genesis 6:3, where the Creator directs that man will live for 120 “Jubilee” Years (50 human years each), which equates to 6,000 years of history that match the 6 Days of Creation. Likewise, the Shemitah Cycle and Jewish Festival system used by the Creator to mark Prophetic Events, gave us a “Bookend” of the Piscean Age: **32-33 AD** matched exactly the Blood Moon Tetrads in **2014-2015**, bringing to a close the end of the Age and the beginning of prophetic events starting with the Jubilee Year that began **Oct 2<sup>nd</sup>, 2016**. The prophetic significance is that all of the Timing Markers given to us in the Scriptures show that **Oct 2<sup>nd</sup> 2016 to Sept 15<sup>th</sup> 2023** are the last 7 years of normal human history. Then follows 7 years of Tribulation, and then 1,000 years of a Millennial Reign of the LORD Jesus Christ from Jerusalem. The fact that the COVID-19 Pandemic (and mRNA Jab) began exactly 3 ½ years (42 months) after the Feast of Trumpets (Jewish New Year) in Oct 2016 is extremely significant on the Prophetic Calendar. Likewise, the Shemitah Cycle in 2015 highlighted and prophetically activated the Blood Moon Tetrads in 2014-2015, which further highlighted and activated the 2016 Jubilee Year – which contained the **Sept 23<sup>rd</sup>, 2017** Prophetic Marker in Revelation Ch 12.

8. All of the above Timing Markers are simply Prophetic Confirmation that events that began with the COVID-19 pandemic are scripted events that fulfill Biblical Prophecy. It allows me to know that the man-made events to install a One-World Government will be complete by Sept 25<sup>th</sup>, 2022. Those plans include an economic crash of the Global Economy (“Great Reset”), installation of a Global Banking System that is cashless, and the conversion to a Mark of the Beast control system where everyone’s ability to work, travel, buy groceries, own property, and shop (etc) are based

upon having the Mark of the Beast – the mRNA Vaccine. Which sufficiently explains to me why there is such a fanatic push to get everyone vaccinated without any medical justification. There is no COVID-19 (isolated or sequenced), there is no pandemic or variations, and there is no need for any government intervention or medical tyranny for people like me, which have a **99.998%** chance of surviving the Influenza with a bioweapon insertion known and mislabeled as COVID-19.

9. The Mark of the Beast according to the Scriptures is identified and perhaps even encoded as 666. That one is not so difficult: Graphene Oxide is a six sided (hexagon) carbon molecule, with 6 protons, 6 neutrons, and 6 electrons. “666.” Graphene Oxide is 99.9% by volume of the mRNA Jab. Included in the Jab to get the biodistribution to all parts of the body is a hydrogel patented by Bill Gates (Patent No WO-2020-**060606**) and called **Luciferase**, which will illuminate via quantum dots when scanned to verify you’ve taken the Vaccine. It also contains a crypto currency financial transaction system powered by your body, and connects to the Cloud via the Graphene Oxide injected into your blood. There is absolutely no doubt in my mind that this is the Mark of the Beast.

10. Against that backdrop, the absurd and insane scramble to get everyone vaccinated makes sense. Especially when credentialed expert after credentialed expert from many disciplines publicly refute the cascade of lies and deceptions created by certain US and UN government agencies. The more the entire COVID-19 Hoax is revealed, the more the government agencies and power brokers scramble to cover their tracks, double down, and prop up their lies. We are at what appears to be a tipping point, where the entire scheme is crashing, and possibly collapsing the Federal Government with it. I am absolutely certain the mRNA Jab is the Mark of the Beast, and is totally unnecessary to solve any medical or health issue. Consequently, I cannot take the vaccine under any circumstances, to include illegal, unlawful, and un-Constitutional orders to do so. The legal experts working with the medical and science experts around the globe indicate there will be a Nuremberg type tribunal for every doctor, nurse, technician, and government employee that administered the vaccine. The charge is “**Crimes Against Humanity**,” and carries the death penalty. Likewise, any military officer or supervisor that requires their subordinates to take the vaccine will also stand trial for Treason and Crimes Against Humanity. I pray it is so!
